Agencies must be community-based organizations (CBOs) or other public or private entities and must have experience in serving students who attend schools with a high concentration of economically disadvantaged students. A Statement of Qualifications may have many partners/collaborators but must have one lead agency as the applicant.

If awarded, contracts will be for an initial period one year with the ability to secure funding for an additional two (2) years, pending a review by SCUSD Expanded Learning Services of progress

will run from approximately July 1, 2022 to June 30, 2023. The actual start and end dates will depend on completion of all procedural requirements associated with the RFQand contracting process.

The amount of each contract will be negotiated upon award and is determined by a number of variables (required attendance, number of students, grant funding allocations).

Applicants interested in single or multiple sites may submit one Statement of Qualifications. The number of Awards funded will depend on the number of schools and funds available. Allocation of funds is final upon successful negotiation and execution of the contract. Bidders selected for an award agree to be bound by the terms of the standard SCUSD Service Agreement, as administered by the SCUSD Youth Development Support Services Department, Expanded Learning Services UniAwards made under this Request for Statement of Qualifications may be subject to approval or ratification by the SCUSD Board of Education the extent the Award exceeds an expenditure above the amount specified in Education Code section 17605 Additional requirements of grant recipients include the following:

- x Grantees are required to maintain 85% of the targeted attendance rate per a single-site.
- x Grantees must work with the SCUSD Expanded Learning Services to demonstrate that progress has been made toward meeting the program goals as outlined in the service agreement; and collect data that addresses the performance indicators for the programs.
- x Grantees and the SCUSD Expanded Learning Services will utilize technology to work together, including, but not limited to, SCUSD Infinite Campus Student Information System (SIS), SCUSD Expanded Learning Services website and websed reporting for attendance.
- x Grantees will send the program manager/site director/site coordinator to monthl y mandatory professional development
- x Grantees will participate within District-wide initiatives as aligned within the SCUSD vision and mission as well as the Youth Development Support Services Office (i.e. Social Justice Youth Development, BullyingPrevention; Obesity Prevention; Red Ribbon Week, etc.)
- x Grantees will work with the school community and the SCUSD Expanded Learning Services to create, refine, and modify the site Expanded LearningProgram plan.

- f Linkages between school-day and after-school personnel
- f High academic standards
- f Remedial educatio

Eligible organizations that receive an award may use the funds to carry out expanded learning activities that advance student achievement and that can be tracked and evaluated. Agencies are encouraged to address as many of these components as possible in heir Statement of Qualifications narrative. There are a number of components to a high-quality expanded learning program. These include but are not limited to:

- *f* Programs that provide assistance to students who maybe truant or highly at -risk to allow the students to improve their academic achievement
- *f* Prevention programs (risk reduction and health promotion), counseling programs and character education programs
- *f* Effective partnerships with community-based organizations, juvenile justice agencies, law enforcement, and youth groups
- f Evaluation of program progress and effectiveness
