Pursuant to Government Code sent8547, the District's and TCS sitial bargaining proposals that relate to matters within the scope of negotiations must be presented at a public theeting. further prohibits negotiation on such proposals until after the public has had an oppositive to informed of the proposal and provide any comments, and the proposal has been adopted by the Governing Board. Since this matter involves the reopening of particular articles of the to allow the Board an opportunity to provide and receive centimathe District's initial proposal for amending the CBA is presented to the Board at this public meeting for a public reading. The District's initial proposal is also presented to the Board at this meeting for final approval and "sunshining."

The belowinitial proposal seeks to negotiate in good faith additions and changes to the CBA that will benefit students and employees are the fiscally sustainable operation of the District in the short and long term. It is the Board's intent that the District work collaboratively with TCS's negotiations team to reach a fair and equitable agreement that protects the interests of students, parents/guardians, unit members, and the District, while ensuring the fiscal solvency of the District.

Propose to negotiate in good faith over employee benefits within the limits of available financial resources. The District may propose other amendments to this Article.
